(1) The amount of qualification examination fees for an applicant is specified as follows:

(2) The amount of admission fees for trading participants is specified as follows:

- Calendar Year 2017 : MMK 7,000,000
- Calendar Year 2018 : MMK 9,000,000

(Note 2) 1.0% of Trading Fees are reserved in YSX as Reserve Funds for guaranteeing settlement of securities transactions for ensuring the safety of settlement of trade in the exchange market.

(Note 3) Where calculated amount of Cancellation Fees is less than MMK 100,000, the fees shall be MMK 100,000 and where the amount is more than MMK 10,000,000, the fees shall be MMK 10,000,000.

(4) The amount of procedural fees pertaining to waiver of trading qualification charged to a trading participant is specified as follows:
