Allow Securities Companies to purchase the Government Treasury Bonds

for

10% of paid up Capital

19th October 2016

1. In accordance with the paragraph 2(c) of the Instruction No. (1/2015) of the Securities and Exchange Commission of Myanmar, the securities companies have subscribed the minimum paid up capital of MMK 15 billion. Regarding the paragraph 2(h) of this Instruction, 10% of the paid up capital which is MMK 1.5 billion is allowed to purchase government treasury bonds sold by the Central Bank of Myanmar starting from the Government Securities Auction held on 20th September 2016.
2. After the purchase of government treasury bonds, Securities Companies shall submit the situation of purchasing, redeeming and additional purchasing to the Commission on time.
