On 4th March 2022, SECM issued Notification (1/2022) regarding the approval on setting up the second board of YSX with named as the "Pre Listing Board -PLB". In the notification, it prescribed main objectives of PLB establishment, matters related with securities registration, registration advisor and matters need to be followed by company which applied for registration at PLB, etc. Business regulations and operation manual for securities registration at PLB are underway to issue to public soon. 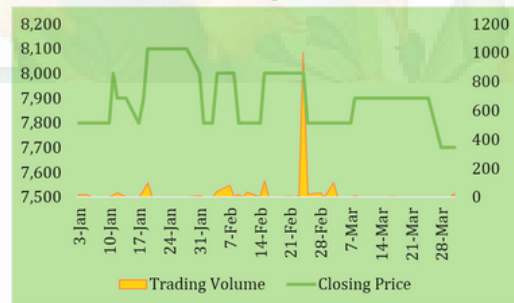
