"NEW LISTING: 8TH LISTED COMPANY-MAEX" ON 3RD JULY

Myanmar Agro Exchange Public Co., Ltd. (MAEX) is allowed to list on Yangon Stock Exchange (YSX) on 3rd July 2023, as the Eighth Listed Company, with the based price of Ks.1800. The listing ceremony was held at YSX Building which located at 24-26, Sule Pagoda Road, Yangon at 9:00 am on that day.

At the ceremony, Deputy Minister for Ministry of Planning and Finance and the Chairman of SECM, H.E U Maung Maung Win delivered an opening remark, and he highlighted importance of capital market which providing necessary fund to private sector development, progressive improvements in Myanmar stock markets and attract to more public companies to enter to the market. After that U Win Naing Oo, Managing Director of YSX, delivered remarks and U Win Aung, Chairman of MAEX delivered thanking remark to the SECM and the YSX for scrutinizing and approving the company to be listed on YSX. The ceremony was successfully concluded by ringing the "Aung-Ze-Ya-Tu Bell" for first listing and share trading.

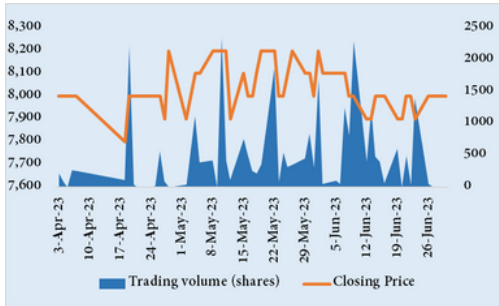

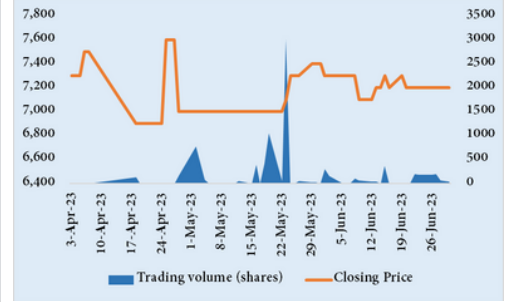

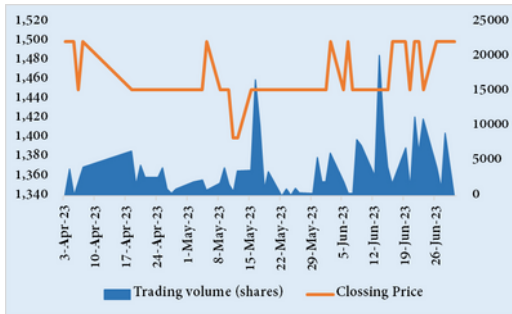

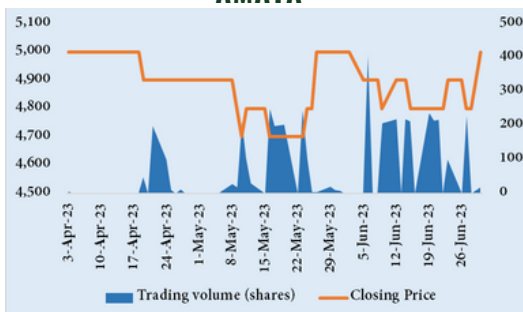

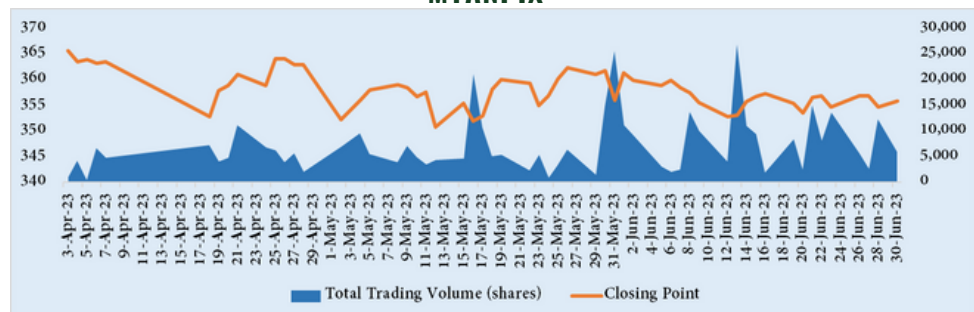
