FIRST ROUNDTABLE DISCUSSION FOR PRE LISTING BOARD WAS HELD ON 8TH SEPTEMBER 2023

With aims to explain more detail about application procedure and registration criteria of PLB which stipulated in SECM notification (1/2023) and to provide necessary technical support to candidate companies which are interested to go registration on the Pre-Listing Board, 1st Roundtable discussion on PLB was held at YSX on 8th September 2023. Total number of attendees were over 40 and 20 public companies attended. Responsible official from SECM and YSX responded enquiries arising from attendees (companies) during the event.

YSX Basic Stock Investment Training Course 002/2023 was opened on 7th October 2023 for providing learning opportunity to investors and fresh learners via online. 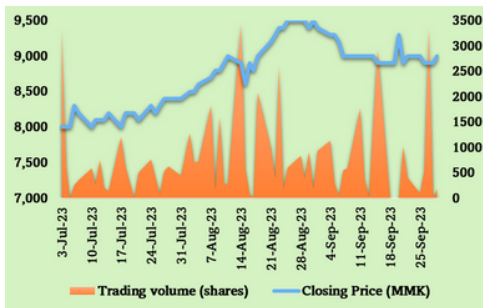

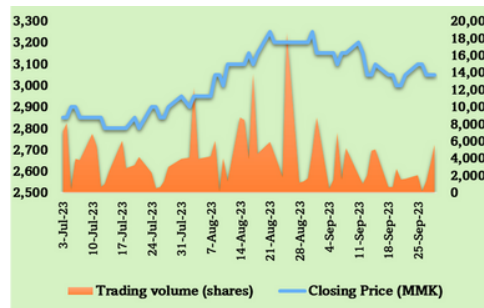

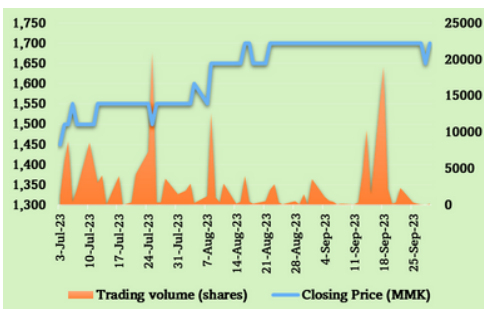

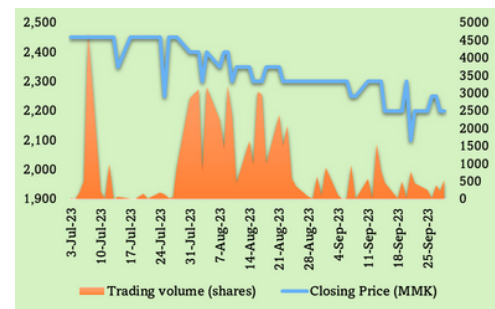

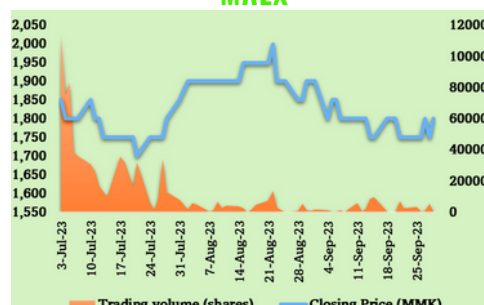

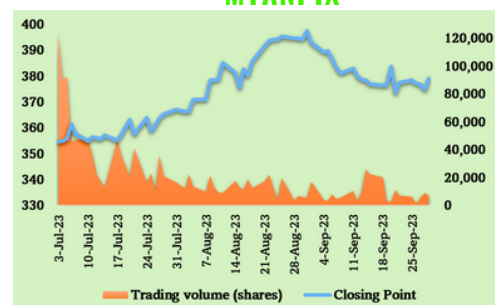
