The scope of activities covered by this certificate is for the installation and maintenance of telecommunication services, internet service provider and the manufacture of top-up-cards. • 20th May 2016 - The Company was converted to a public limited company under the Companies Act in the name of TMH Telecom Public Co. Ltd.
